What is this product?

Type

This is an investment fund established as a company with variable capital and segregated liability between sub-funds, incorporated with limited liability under the laws of Ireland.

Objectives

Investment objective The Fund is designed for long-term investors who wish to build capital over a minimum five-year rolling period through investment in a portfolio of global companies. The target is to achieve a return on a compound annualised basis exceeding the OECD G7 CPI plus 8% per annum over a five-year time period.

Investment policies The Fund aims to achieve its investment objectives by principally investing in equities issued by large capitalisation companies, irrespective of specific geographical location or sectoral focus listed or traded on Recognised Exchanges throughout the world. It is possible that investments may also be made in bonds where the Investment Manager's process and analysis, which focuses on equities, identifies an opportunity for investment in bonds, should a bond present the possibility to give a better return than the equity identified.

Where the Fund invests in bonds, they may include convertible bonds with equity linked notes, government or corporate bonds with a fixed and/or floating rate, which are listed or traded on a Recognised Exchange, subject to the investment restrictions listed in the Prospectus. The investment rating of those bonds will be investment grade.

Investments in the Fund may include financial derivative instruments. Such instruments may be used to obtain, increase or reduce exposure to underlying assets and may create leverage; therefore their use may result in greater fluctuations of the Net Asset Value of the Fund. The Investment Manager will ensure that the use of derivatives does not materially alter the risk profile of the Fund.

Benchmark The Fund is actively managed and whilst it is managed in reference to the benchmark: OECD G7 CPI plus 8%, the benchmark does not in any way constrain the management of the Fund. The Sub-Fund uses the OECD G7 CPI plus 8% for performance comparison reason only.

Redemption and Dealing You can buy, sell and switch shares of the Fund on demand on any Business Day as defined in the "Definitions" section of the Fund's Prospectus.

Distribution Policy It is intended that dividend income will be distributed as set out in the "Dividend Policy" section of the Supplement of the Fund.

Launch date The Fund was launched on 17/12/2014.

Fund Currency The base currency of the Fund is USD. This share class currency is EUR.

Conversion of units/shares More share classes are available for this Fund, and you can find further information on <https://www.vamllp.com/>. It is possible to exchange your shares in the Fund for shares in other sub-funds of the Company, details of which can be found in the Prospectus.

Asset Segregation The Company is an umbrella fund with segregated liability between its sub-funds. The prospectus and the periodic reports are prepared for the Company as a whole.

Intended retail investor

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The PRIIP manufacturer, Waystone Management Company (IE) Limited, is not entitled to terminate the product unilaterally.

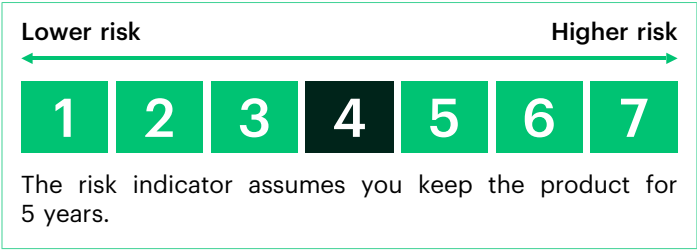

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the Fund to pay you.

Performance scenarios

What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should the Fund default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.
